Committee Reports:

By-Laws –Lyndsey Edgerton and Garrett Killan led discussion on Term of Office for Staff Senator. The By-Law states at this time:

Section 1.5: Terms of Office

Staff Senators will be elected by a majority of votes cast by eligible employees within a division, and will serve a two-year term of office beginning June 1 (voting eligibility requirements can be found in Article II Section 2.1 Election Procedure C). If elected, he/she may serve two consecutive terms. Upon the completion of two consecutive terms and following a one-year break, the employee may seek re-election to the Staff Senate. By Law Committee suggest removing the words following a one year break – this will mean a staff senator can serve continuously as long as nominated and elected by votes to remain on the senate every 2 years.

*VOTE -Motion was put forth by Lyndsey Edgerton to make the change to the new wording for terms of office in the bylaws. - Bailey Steckbauer made the motion, Amy Eason second and green/red card vote - It was passed with showing of green cards to change bylaws.

Sarah Jones asked if it was necessary for have By-Laws Committee every year or should it be an Adhoc Committee.

Discussion from question: Bylaws should be flexible where it doesn't have to change at every item. Executive Committee oversees the bylaws or Adhoc Committee Recommended that they bylaws be reviewed yearly.

Suggested maybe not to have so many committees but do more Adhoc Committee to focus on the need at the time.

Membership and interest may increase if we go to less committee and more to Adhoc Committee.
