#### **Executive Committee Comments**

Chair – Elect – Kimrey Miko

# **By-Laws Committee Report**

Proposed Revisions to the By-Laws of the East Carolina University Staff Senate

Revise the current text in Article I. Section 1.3 with additions noted in **bold** print and deletions in strikethrough

Section 1.3: Alternate Senator Qualifications/Duties – A maximum of two (2) Alternate Senators for each Division will be selected based on the next highest number of votes received:

- A. Alternate Senators are non-voting members unless serving in a Senator's absence at which time they will fulfill the voting duties of the Senator or they are filling a Senator's vacated seat. Qualifications shall consist of same requirements as listed in <a href="Article I Section 1.2">Article I Section 1.2</a>: Senator Qualifications/Duties
- B. Alternate Senator duties include
  - a. A attending, in a Senator's absence, all regular monthly meetings, as well as, special- or-called meetings.- and
  - b. Following the attendance policy found in <u>Article I Section 1.8:</u> Attendance Policy.
  - c. S serving with vote on committees of the Staff Senate and may be elected to serve as a Chair or Chair-elect of a standing committee excluding the Executive Committee. If an Alternate Senator is elected to be Committee Chair-elect, then the Chair of the committee will inform the Executive Committee who has the authority to extend the Alternate Senator's term for one year to allow the additional year of service as Committee Chair, following the year of service as Chair-elect.
  - d. Making themselves known to their constituents, indicating how they can be contacted. They shall be willing to hear concerns, to receive information and suggestions, and to communicate these effectively to the Staff Senate. In turn, Alternate Senators must keep their constituents well informed of the work of the Senate and matters in which the administration solicits input from the Senate.
  - e. Voting on their committee issues.

#### So that the text would read as follows:

"Section 1.3: Alternate Senator Qualifications/Duties – A maximum of two (2) Alternate Senators for each Division will be selected based on the next highest number of votes received.

Alternate Senators are non-voting members unless serving in a Senator's absence at which time they will fulfill the voting duties of the Senator or they are filling a Senator's vacated seat. Qualifications shall consist of same requirements as listed in <a href="Article I Section 1.2">Article I</a> Section 1.2: Senator Qualifications/Duties.

Alternate Senator duties include attending, in a Senator's absence, regular monthly meetings, as well as, special-called meetings and serving with vote on committees of the Staff Senate."

Replace the current text in Article I. Section 1.8 with new text noted in **bold** print

# Section 1.8: Attendance Policy

A senator should notify the secretary of the Senate in advance of an absence from a regular or special-called meeting. The advance notice of an absence, and request for alternate representation, will prevent the absence from being considered grounds for removal from the Senate.

A senator with three (3) or more absences from regularly scheduled monthly meetings during a year will meet with the Executive Committee to discuss the matter on a case-by-case basis. Following the meeting, the committee will determine whether to recommend to the division Vice Chancellor or designee removal of the senator from the Senate. If a senator is awarded a medical leave and an alternate attends in the senator's seat, the three (3) or more absences will not be invoked.

A. If a Senator or Alternate Senator misses more than (2) two regular monthly meetings due to unexcused absences:

The Staff Senate Executive Committee shall contact the Senator or Alternate Senator with a copy to the Executive Committee and the Associate Vice

Chancellor for Human Resources reminding the Senator or Alternate Senator of attendance requirements.

B. If a Senator or Alternate Senator misses more than (3) three regular monthly meetings due to unexcused absences:

The Staff Senate Executive Committee shall send a letter to the Senator or Alternate Senator with a copy to the Senator or Alternate Senator's

supervisor. With advance notice of an extended absence, the Senators absence will not be considered grounds for removal from office.

C. If a Senator or Alternate Senator misses (4) four or more regular monthly meetings due to excused or unexcused absences:

The Staff Senate Executive Committee will contact the Senator or Alternate Senators supervisor and use their discretion as to whether to initiate removal

per Article I Section 1.7 Removal from Office.

D. The Senator or Alternate Senator should notify the Executive Committee via the Secretary in advance of an extended absence of (3) three meetings or more. With

advance notice of an extended absence, the Senator or Alternate Senator absence will not be considered grounds for removal from office.
