• Lee Ann Goff – Director of University Benefits

- State Health Plan Updates/Changes for 2018
- Open enrollment now until 10/31/17
- o Got rid of 85/15 (CDHP)
 - Did this to reduce costs not cost effective and not many people enrolled in it
- o Got rid of the two wellness credits you saw with the 80/20 plan.
- o Employee only premiums raised for both 80/20 and 70/30.
- o Benefits of 80/20 and 70/30 plan are the same such as co-pays
- O System defaults you to 70/30. You have to log in and enroll in 80/20 if you want that plan.
 - Still have to log in and accept the 70/30 plan as well.
 - There is a premium for 70/30 this year (\$25/month).
- o Higher premiums if you smoke
- o 80/20 still need to list PCP as you will get the lower co-pay at their office, but it will not help lower your premium
- \circ 80/20 = \$110 if employee only and you smoke per month
- \circ 70/30 = \$85 if employee only and you smoke per month
- o Enroll in QuitLine NC or do tobacco free credit, you get a \$60 credit in each plan
- \circ 80/20 = \$50 monthly, 70/30 = \$25 monthly if you get the credits
- o No change in plan benefits for 2018 (copays, prescriptions, etc.)
- O Vidant not blue options designated (B.O.D.) hospital you have to pay the first \$450 on 80/20; \$0 if you go to a B.O.D. hospital
- \circ 70/30 = no ACA preventive services for free; 80/20 = ACA preventive services are zero cost
- Only people that will get a new insurance card are people that make changes to their plan or new enrollee's if you keep the same plan, you will not get a new card
- Write down your confirmation number from your enrollment will need this to look up what you did if there are any issues.
- New eye insurance EyeMed
 - Larger network
 - Lower premiums and higher frame and contact lens allowance
- o Dental: lower rates on high option
- o FSA you have to enroll in each year

New Business

- Amy Sweers By-Laws Committee
 - o Propose a by-laws change in section 2.1
 - 2.1 A: change to January from February
 - 2.1 C: change to a minimum of twenty-one (21) days with a maximum of thirty (30) days from only saying twenty-one (21)
 - o Shelby Donnelly: reason for second change -2.1C?
 - Amy: In case there is ever inclement weather, and we have to miss work
 - How will you open nominations?
 - Start with 21 work days count them out. If they need to extend for any reason they will count out 9 more work days
 - Will depend on the circumstances
 - Goal is to keep it 21, but allows for room if unavoidable circumstance happens
 - o Motion to change 2.1 A and C: made by Candace Darden, second: Kara Ousley
 - Motion passed all voted yes
 - o Joel Stocks asked that we send out updated by-laws to all of SS once updated?
 - Yes we will
- Discuss adding a Parliamentarian and/or Vice Chair position to the Staff Senate Executive Committee
 - o Reason to add Parliamentarian? To aid with Roberts Rules Of Order (RROO) and work closely with by-laws committee to help out
 - Will know RROO in and out
 - Reason to add Vice Chair? To assist if the chair leaves mid-year, they would be able to step right
 in, chair elect stays where they are (to keep learning), that way someone would not have be chair
 for 1.5 years or so
 - Vice Chair would be able to step in cover
 - Nick Balestrieri: Do other organizations have chair-elects?

- Yes; this mirrors staff assembly
- Lisa Hodges: Parliamentarian come from inside SS or outside person? Since they would have to know RROO
 - Could be either way could be a consultant, etc.
- Joel Stocks: How would VC and Chair Elect duties differ?
 - VC would be a silent member, but be on the same page as the Chair shadows them
 - VC would step in to cover if chair had to leave their duties
 - Make the transition easier while CE still learns their role
- Helen Lovett: What are the requirements to be a parliamentarian and how are they voted on? What are the qualifications for a parliamentarian and how are they voted on?
 - We have not ironed that out yet
 - Dawn King: discussed a lot of options
 - o Consultant or voting member of SS (member of SS)
- Brian Stutz like the idea of a vice chair, but thinks we need to add other duties to this position.
- Shelby Donnelly: Vice chair would be helpful to chair to spread out going to committee meetings – won't have it to where it is as much time out of the office for the chair
- Nick Balestrieri: if we do add a vice chair how would that affect the money that is allocated to the chair position to help hire someone to assist their office while they are absent? If we add a vice chair, but not a parliamentarian, could we have the chair elect act as the parliamentarian they would need to know RROO.
 - HR would have to approve the time commitment
- Helen Lovett: how much work would have to be done to update all the documents and job descriptions? How much work would have to be done to update all of the policy and procedural documentation for this position?
 - It would be a lot, that's why we want to start on it now
 - What is the chair elect not doing now, that they could be doing can their duties increase?
 - Is there an equitable distribution of work?
 - Come January LuAnn will be going to a majority of the meetings instead
 of Kimrey, to get her feet wet; start taking a larger role in staff senate
 meetings start integrating her more that she is now
- Dawn King: vastly different skill set between being a parliamentarian and being a chair
 - One is keeping meeting in order, one is leading the meeting
- Lisa Ormond: may be helpful to show them the duties of a vice chair and the duties of the Chair elect – that way they can see the difference
 - Kimrey Miko something we can get together to send out
- Vote in favor of working toward a vice chair position: 5 opposed, the rest yes; Parliamentarian: 3 opposed, the rest yes
